"Deck the Stalls is our final fundraising event of the year for Save the Horses Rescue. Funds raised are used to rescue, feed and rehabilitate abandoned, abused and neglected horses and other farm animals," explains Cheryl Flanagan, founder of Save the Horses Rescue. "We currently are caring for and providing a home to about 130 animals. Since we don't receive federal or state funding, we rely on fundraising events like Deck the Stalls and donations from generous individuals and companies to cover our operational costs as well as volunteers to manage the daily farm needs."
